On the other hand, we have watched both the stock market boom and the IRS increase the <u>tax deduction benefit</u> for donating to charitable organizations in 2020 (which now allows individuals to deduct qualified contributions of up to 100% of their adjusted gross income vs. the standard 60% previously).

We are gearing up to visit our Visions Ethiopia team hopefully early 2021, and we are in great need of supplies to equip our new Visions Center for the Deaf in Awassa. ### Sponsor a student at our new nonprofit boarding school in Nicaragua

While **Escuela Vera Angelita** will not officially open its doors until July 2021, the campus is essentially built and teacher training starts in just a few weeks! Our inaugural student body will consist of 60 students total from Grades 5-7 (20 students per grade). In addition to an education like no other, these young women will be given room & board for the entirety of the academic year, transportation to/from home during the breaks, full medical care, all their uniforms & clothing, and much more.

The cost to sponsor a student is \$5,000/year. If you would like to become a sponsor and make a donation now, we will simply earmark your gift until the students are brought on campus in June 2021.

In general, sponsors can choose how involved they want to be (or not), such as doing virtual monthly "visits" via Zoom, exchanging letters, or even coming to stay with us in our onsite accommodation for guests for a few days each year.

Monthly donors are the backbone of our organization and ensure our ability to continue our work without interruptions. Simply set up a monthly recurring donation via PayPal by visiting our <u>website</u>, and we will keep you regularly informed of our work & its impact.

## **VISIONS' 2020 PROGRAM HIGHLIGHTS**

## Sri Lanka

- Funded the construction of a new 4-unit Elder Care facility and conducted a 12-week virtual leadership development training for staff at Moolai Cooperative Hospital in Jaffna
- Despite some roadblocks caused by the pandemic, the 10-month *Ezhuvazh* leadership development & English training program for young women



(which was conducted by CACM and supported in-part by Visions) was successfully completed this year.

- Facilitated scholarships for 6 young women (all of whom are *Ezhuvazh* graduates) to begin their studies (\*virtual for now) at Asian University for Women in Bangladesh, with another 2 *Ezhuvazh* graduates starting this January
- Supported e-learning and internship initiatives of <u>Care for</u> <u>Education</u> and <u>Noolaham Foundation</u>

## **ETHIOPIA**

 Launched a new private Visions Center for the Deaf in Awassa, Ethiopia, which is staffed by 5 full-time employees (2 interpreters & 3 Deaf educators)

- Our Visions Ethiopia team took special efforts to keep students in Bahir Dar & Awassa connected to learning while public schools remained closed for the majority of the year
- Conducted our first servicelearning trip in Awassa for



two weeks for a team of 20 students and faculty from Nazareth College

## INDIA

- Hard hit by the pandemic, our <u>Visions India</u> team had to find alternative ways of reaching our students and quickly shifted almost all of our programs to a strictly digital delivery.
- Tablets and bluetooth keyboards were provided to 27 of our university scholars in order to adapt to an all-virtual instruction



# NICARAGUA

- Made major strides in building the school, residences, farm and campus as a whole that comprise the 385-acre Vera Angelita Estate
- Finalized our curriculum and education plan, which



is centered around the "Education for Sustainable Development" model, and will further prioritize technology, English, and vocational skills, to name just a few of our learning priorities.

 Built out our Visions Nicaragua team, including estate & farm managers, school administrators, teachers, chef, doctor, operations managers, etc.
We now employ a staff comprised of nearly 120 people!
